Defend ATMs from jackpotting and theft

- Protect your branch and ATM network with Verkada's easy-to-install mini split cameras. Built-in tamper alerts are triggered when vibration or movement is detected, helping security teams respond to physical attacks in real time.
- Unlock a more comprehensive view of the incident with both video footage and optional audio from the scene.

Proactively protect drive-thru ATMs

- Enhance security at drive-thru ATMs with license plate recognition (LPR) enabled cameras that automatically capture plates of suspect drivers.
- Search by license plate or by vehicle attributes such as color, make, and body type, which helps when plates are obscured or missing. Receive alerts when a flagged vehicle is detected returning to a branch.


Fight check fraud with smarter investigations

Secure sites against suspicious activity


